#### (II) <u>SUGGESTED BROAD THEMES</u>

The ILCB accepts pieces based on a broad spectrum of themes, so long as it pertains to International Law. These can *Public International Law, Private International Law, Anti-trust Law, International Commercial Arbitration, International Investment Law*, etc.

#### (III) FORMATTING GUIDELINES AND WORD COUNT

- Submissions can be made on a Word file (.doc or .docx format). Pieces can be written on an A4 sheet with normal margins (2.54 cm on each side).
- Text font size 12, Times New Roman. Headings and sub-headings can be in font size 14, Times New Roman. Line spacing - 2.0 (double-spaced).
- Form of Submissions & Word Count :
  - a) Blogs: 1500-3000 words
  - b) Short Articles 3000-5000 words (excluding footnotes)
  - c) Long Articles 5000-15,000 words (excluding footnotes)
  - d) Case/Legislative Comments above 1500 words (excluding footnotes)

#### (IV) <u>CITATIONS FOR BLOG/ARTICLES/COMMENTS</u>

- a) **Blogs** Hyperlinking
- b) Short Articles Bluebook (21st edition) or OSCOLA (4th edition)
- c) Long Articles Bluebook (21<sup>st</sup> edition) or OSCOLA (4<sup>th</sup> edition)
- d) Case/Legislative Comments Hyperlinking or Bluebook (21<sup>st</sup> edition) or OSCOLA (4<sup>th</sup> edition)

• Example for hyperlinking:

"Human Rights Treaties confer on States a <u>two-fold obligation</u>, a negative obligation to refrain from violating covenant rights, and a positive obligation to take steps to guarantee rights. The International Covenant on Civil and Political Rights ("<u>ICCPR</u>") recognizes the right to free speech under Article 19 and also prohibits hate speech under Article 20. The same has been recognized by the Human Rights Committee ("HRC") in its <u>General</u> <u>Comment 34</u>.

State parties to the covenant can only restrict the right to free speech if the sanction imposed on the individual is in harmony with <u>the three-part test</u>. It was reaffirmed by the HRC in the case of <u>Svetik vs Belarus (2004)</u> that any restriction on Article 19 must satisfy all 3 prongs, it must be provided by law, it must be in pursuance of a legitimate aim, and finally must be necessary for a democratic society.
